The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 9:30 a.m.

1) **MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, April 19, 2011.**

MOTION: Hudkins moved and Raybould seconded approval of the minutes. Hudkins, Raybould, Smoyer and Heier voted aye. Schorr was absent. Motion carried 4-0.

2) **CLAIMS: Approval of all claims processed through Tuesday, April 26, 2011.**

MOTION: Raybould moved and Smoyer seconded approval of the claims. Raybould, Smoyer, Hudkins and Heier voted aye. Schorr was absent. Motion carried 4-0.

3) **SPECIAL PRESENTATION:**

A. **Commissioners Award of Excellence for March 2011, to Jeremy Carnes, County Records & Information Management.**

The Clerk read the nomination for the record. Brian Pillard, County Records & Information Management, introduced Jeremy Carnes who expressed his appreciation for the award. Hudkins and Kerry Eagan, Chief Administrative Officer, commended Carnes for his service. Smoyer presented a plaque to Carnes.

4) **PUBLIC HEARINGS:**

A. **A Class I liquor license from Sandbar, LLC, d/b/a Branched Oak Marina Sandbar & Grill, 10001 W. Davey Road, Raymond, Lancaster County, Nebraska.**

4) **PUBLIC HEARINGS CONTINUED:**

The public hearing was continued from last week. Heier noted an amendment to the liquor license was received as requested by the Board. The Vice Chair closed the public hearing.

5) **NEW BUSINESS:**

- A. **A resolution for a Class I (beer, wine and distilled spirits on sale only) liquor license for Sandbar, LLC, d/b/a Branched Oak Marina Sandbar & Grill, and a corporate manager liquor license in connection with the Class I liquor license for Branched Oak Marina Sandbar & Grill, located at 10001 W. Davey road, Raymond, Lancaster County, Nebraska. (R-11-0029)**

MOTION: Smoyer moved and Hudkins seconded approval of the resolution. Raybould, Smoyer, Hudkins and Heier voted aye. Schorr was absent. Motion carried 4-0.

4) **PUBLIC HEARINGS:**

- B. **An amusement license application from Linh Quang Buddhist Center, Inc., for events on Saturday, May 14; Saturday, August 13; and Saturday, September 3, 2011, located at 3175 W. Pleasant Hill Road, Lincoln, Lancaster County, Nebraska.**

The Vice Chair opened the public hearing. Tuyet Kieu, Linh Quang Buddhist Center, was administered the oath. She said noise variance permits have been approved by the Health Department and she has verified nothing needs to be done with the City. All three events are free of charge and open to the public. Each event features a cultural performance and live concert with an anticipated attendance of 500 to 700 people. The Vice Chair closed the public hearing.

5) **NEW BUSINESS:**

- B. **An amusement license application from Linh Quang Buddhist Center, Inc., for events on Saturday, May 14; Saturday, August 13; and Saturday, September 3, 2011, located at 3175 W. Pleasant Hill Road, Lincoln, Lancaster County, Nebraska.**

MOTION: Smoyer moved and Raybould seconded approval of the amusement license. Smoyer, Hudkins, Raybould and Heier voted aye. Schorr was absent. Motion carried 4-0.

- C. **A resolution in the matter of transferring appropriations from the General Fund Miscellaneous Budget to the General Fund Juvenile Court Budget. The amount to be transferred is \$350,000. (R-11-0030)**

Dennis Meyer, County Budget & Fiscal Director, said the Juvenile Court needs funds transferred to cover attorney fees for the year. He said this was discussed during the midyear budget meeting with Juvenile Court Judge Roger Heideman.

Hudkins asked if there are increased boarding contracts. Meyer said the boarding contracts have decreased in an attempt to make up for the increased attorney fees. Hudkins expressed concerns over the high cost.

5) **NEW BUSINESS CONTINUED:**

Raybould discussed the switch from contracted attorneys to court appointed attorneys in 2009 at a different rate of reimbursement. She expressed her wishes to work with the judges to review the contract arrangement. Meyer said the Juvenile Court has made some changes and are monitoring costs. He said some back billing by the attorneys has likely contributed to the fees.

Hudkins said the costs have been incurred already and must be paid but other options need to be reviewed. Meyer said this would be a part of discussions during upcoming budget meetings.

Heier noted juvenile cases often have multiple attorneys, which increases costs.

MOTION: Smoyer moved and Heier seconded approval of the resolution. Smoyer and Heier voted aye. Hudkins and Raybould voted nay. Schorr was absent. Motion failed 2-2.

Smoyer agreed the Board should be more cognizant of what is spent in the court system, but he noted it is mandated by the State.

Hudkins agreed the attorney fees need to be paid, but he would like to see a plan of action rather than asking for money after it has been spent. Raybould agreed with Hudkins, noting the obligation to the taxpayers.

Meyer cautioned that the bills would not be paid once the total Juvenile Court budget is spent without additional spending authority from the County Board.

Heier questioned if the item could be brought up again before the Board. Hudkins said he would reconsider if a plan of action were brought before him.

- D. A contract with Hartmann Construction Company, in the amount of \$792,367.36, for grading construction on NW 70th Street, S. 1st Street, S. 98th Street and Saltillo Road; Project No. 11-27. (C-11-0210)**

MOTION: Hudkins moved and Raybould seconded approval of the contract.

John Austin commended the use of a local contractor.

ROLL CALL: Hudkins, Raybould, Smoyer and Heier voted aye. Schorr was absent. Motion carried 4-0.

- E. A contract between Kenwood USA Corporation, the City of Lincoln and Lancaster County for two-way communications equipment and related accessories. The County will pay for products and services pursuant to State of Nebraska Contract No. 11181 OC. Term of the contract is January 1, 2011, to June 30, 2011. (C-11-0211)**

MOTION: Raybould moved and Hudkins seconded approval of the contract. Raybould, Smoyer, Hudkins and Heier voted aye. Schorr was absent. Motion carried 4-0.

5) **NEW BUSINESS CONTINUED:**

- F. **A lease agreement between Lancaster County and the Department of Administrative Services, State Building Division, acting on behalf of the Department of Corrections, for approximately 6,675 square feet of office space in Trabert Hall, located at 2202 S. 11th Street, Lincoln, Nebraska. Term of the agreement is May 1, 2011, to April 30, 2012. The Department will pay the County \$4,590.10 per month for the leased space. (C-11-0212)**

MOTION: Raybould moved and Smoyer seconded approval of the agreement.

Hudkins said he was glad to fill the space and have the income, but he appreciated the lease being done one year at a time.

John Austin questioned the Board's interest in selling Trabert Hall. He did not feel the building should be sold.

ROLL CALL: Smoyer, Hudkins, Raybould and Heier voted aye. Schorr was absent. Motion carried 4-0.

- G. **A second amendment to County Contract No. C-09-0137 with Legacy International, Inc., d/b/a Legacy Inmate Communications, for inmate phone services for County Correctional Facilities. The parties are amending the agreement to direct commission records and payments to Praeses, LLC. (C-11-0213)**

MOTION: Raybould moved and Hudkins seconded approval of the amendment. Smoyer, Hudkins, Raybould and Heier voted aye. Schorr was absent. Motion carried 4-0.

- H. **An intercompany IT services agreement between Southeast Nebraska Behavioral Health Information Network, d/b/a the Electronic Behavioral Health Information Network, and Lancaster County, on behalf of the Community Mental Health Center, for the implementation, operation, maintenance and access to a regional health information network and shared database applications of patient information. Cost to the County shall be a one-time fee of \$73,484 for implementation, licensing and training. The County shall also pay a monthly fee of \$1,979.06, commencing April 26, 2011, for ongoing operation and maintenance of the software applications. (C-11-0214)**

MOTION: Raybould moved and Hudkins seconded approval of the agreement. Hudkins, Raybould, Smoyer and Heier voted aye. Schorr was absent. Motion carried 4-0.

- I. **A renewal of a maintenance agreement with Environmental Systems Research Institute, Inc. (ESRI) in the amount of \$16,100, for ArcInfo software used by the Lancaster County Engineer's and County Assessor/Register of Deeds' Geographic Information System (GIS). Term of the agreement is July 21, 2011, to July 20, 2012. (C-11-0215)**

Hudkins asked if the annual renewal was the same amount as in previous years. Erik Hubl, GIS Manager, said one seat was added a few years ago for a total of eight - five for the County Engineer and three for the County Assessor. He felt the cost would remain steady.

5) **NEW BUSINESS CONTINUED:**

Smoyer asked if it was possible to have a multiyear deal to cut costs. Hubl said there is an overall site license for larger organizations. If the City, County and various entities combined, there could be a potential reduction.

MOTION: Smoyer moved and Raybould seconded approval of the agreement renewal. Raybould, Smoyer, Hudkins and Heier voted aye. Schorr was absent. Motion carried 4-0.

- J. **An amendment to County Contract No. C-10-0118 with Family Violence Council for the "Improving the Violence Against Women Coordinated Response in Lancaster County" program. The amendment extends the ending date of the contract to June 30, 2011. (C-11-0216)**

MOTION: Raybould moved and Hudkins seconded approval of the amendment. Heier, Smoyer, Hudkins and Raybould voted aye. Schorr was absent. Motion carried 4-0.

- K. **A mini-grant application and award with the Nebraska Office of Highway Safety in the amount of \$6,160 for selective overtime enforcement for Lancaster County's participation in the statewide "Click It or Ticket" mobilization May 23, 2011, to June 5, 2011.**

MOTION: Hudkins moved and Raybould seconded approval of the application and award. Smoyer, Hudkins, Raybould and Heier voted aye. Schorr was absent. Motion carried 4-0.

- L. **An agreement with Elliott L. Rustad to provide specialized medical care and assistance to Lancaster County General Assistance clients who have pending claims with the Social Security Administration and may be eligible for retroactive Medicaid benefits. The agreement sets forth a reimbursement arrangement in which the County will provide payment for the medical care and Elliott L. Rustad will reimburse the County if/when the General Assistance client is later determined eligible for Medicaid reimbursement. The agreement is effective upon execution of both parties and contains a 30-day termination provision. (C-11-0217)**

MOTION: Hudkins moved and Raybould seconded approval of the agreement. Hudkins, Raybould, Smoyer and Heier voted aye. Schorr was absent. Motion carried 4-0.

- M. **Employer's acceptance of voluntary insurance program and application for group insurance with Allstate for American Heritage Life Insurance.**

MOTION: Hudkins moved and Smoyer seconded approval of the program and application. Smoyer, Hudkins, Raybould and Heier voted aye. Schorr was absent. Motion carried 4-0.

- N. **Reappointments of Martha Brown, Sheryl Jordan and Corine Simon to the Aging Partners Area-wide Advisory Council for three-year terms to expire July 1, 2014.**

MOTION: Heier moved and Raybould seconded approval of the reappointments. Raybould, Heier, Smoyer and Hudkins voted aye. Schorr was absent. Motion carried 4-0.

5) **NEW BUSINESS CONTINUED:**

- O. **A political subdivision tort claim filed against Lancaster County Corrections by Delos E. Pumel for lost property in the amount of \$9.90.**

MOTION: Hudkins moved and Smoyer seconded denial of the tort claim based on the department director's recommendation. Smoyer, Hudkins, Raybould and Heier voted aye. Schorr was absent. Motion carried 4-0.

- P. **A political subdivision tort claim filed against Lancaster County Corrections by Scott G. Nannen for alleged lack of medical attention in the amount of \$500-1000.**

Scott Nannen discussed the expenses he incurred from his injuries, which total \$1,300.24. He requested \$1,600. Nannen said the injury occurred when he was arrested by the Lincoln Police. While incarcerated, he had an x-ray taken and never received the results. Upon his release, he had another x-ray, which he felt he should not have had to do if he had received the original results.

Hudkins questioned what happened during the incident. Nannen said the injury occurred when he was pushed onto the ground during his arrest. Hudkins stated the report said jail staff arranged for x-rays to be taken on March 29, the day after Nannen was taken into custody, and over-the-counter medication was given at that time. Nannen said he received ibuprofen, but he never received information on his injury. Hudkins said the report stated a sling was offered to Nannen, which he refused. Nannen said he refused the sling because he had already been without a sling all week. Hudkins noted the sling was offered on March 31, two days after the arrest. Nannen stated he was offered a sling on Saturday night, which would have been April 2.

Nannen submitted his bills for the record (Exhibit A).

MOTION: Hudkins moved and Smoyer seconded denial of the tort claim based on the department director's recommendation. Hudkins, Raybould, Smoyer and Heier voted aye. Schorr was absent. Motion carried 4-0.

FRACTURE: ELBOW

A FRACTURE is the medical term for a BROKEN BONE. This may be a small crack in the bone; or a major break with the broken parts pushed out of position. Elbow fractures can take from 4-12 weeks to heal, depending on the type. Treatment is usually with a splint for the first few days followed by a long arm cast. Some types of elbow fractures require surgery to put the bone fragments back into place.

HOME CARE:

- 1) Place an ice pack on the splint/cast over the injured area for 20 minutes every two hours the first day. Continue this 3-4 times a day until the pain and swelling start to go down.
- 2) Keep the splint/cast completely dry at all times. Bathe with your splint/cast well out of the water, protected with a large plastic bag, rubber-banded at the top end. If a fiberglass cast or splint gets wet, you can dry it with a hair-dryer.
- 3) You may take Tylenol (acetaminophen) or ibuprofen (Advil, Motrin) for pain, unless another pain medicine has been prescribed.

FOLLOW UP with your doctor or this facility as advised. If a splint/cast was applied, it should be checked in 24 HOURS to be sure that it has not become too tight from swelling. Look for the warning signs below.

[NOTE: A radiologist will review any X-rays that were taken. We will notify you of any new findings that may affect your care.]

RETURN PROMPTLY or contact your doctor if any of the following occur:

- The plaster cast or splint becomes wet or soft
- The fiberglass cast or splint remains wet for more than 24 hours
- Increased tightness or pain under the cast or splint
- Fingers become swollen, cold, blue, numb or tingly



A complaint to the Citizen's Police Advisory Board must be filed within 45 days of the alleged occurrence. A complaint may be made to the Citizen's Police Advisory Board even when the Internal Affairs Office of the Police Department is also investigating the complaint.
