The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 9:30 a.m.

1) **MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, June 19, 2012.**

MOTION: Hudkins moved and Smoyer seconded approval of the minutes. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.

2) **CLAIMS: Approval of all claims processed through Tuesday, June 26, 2012.**

MOTION: Smoyer moved and Raybould seconded approval of the claims. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

Item 5E was moved forward on the agenda.

3) **SPECIAL PRESENTATIONS:**

A. **Introduction of Bruce Trautwein, Lancaster County Veterans Service Committee – Gary Chalupa, Veterans Service Officer. (See 5A for correlating item.)**

Gary Chalupa reviewed the process for nominations to the Lancaster County Veterans Service Committee and introduced Bruce Trautwein. Trautwein discussed his history with the military and the importance of making veterans aware of the benefits available to them. Chalupa noted that Trautwein has met statutory requirements for the appointment.

SPECIAL PRESENTATIONS CONTINUED:

- B. **Visitors Promotion Fund Grant to Friends of Lied-Lied Center for Performing Arts for the purchase of a new light board system – Bill Stephan, Executive Director. (See 5B for correlating item.)**

Bill Stephan thanked the County Board for their past support and explained the importance of installing a new light board system. He said the total cost of the new light board would be \$24,000, including the \$10,000 request for grant funds. Stephan said the old light board would be used as a backup for now and eventually donated. He provided a brochure of the 2012-2013 season (Exhibit A).

4) **PUBLIC HEARINGS:**

- A. **Increase of appropriations for the Weed Control Fund, in the amount of \$4,500, for additional fuel costs along with additional contractor payments due to increase in workload. (See 5C for correlating item.)**

The Chair opened the public hearing.

Dennis Meyer, Budget & Fiscal Director, was administered the oath. He explained that the Weed Control Fund is a separate fund and can only be amended by holding a public hearing. Meyer discussed the additional revenue generated, including a State grant, for Weed Control.

Hudkins asked about fees charged to people who do not control weeds on their property and possible liens on those properties. Meyer said some of that money is always outstanding, and a lot of the revenue crosses fiscal years.

The Chair closed the public hearing.

5) **NEW BUSINESS:**

- A. **Appointment of Bruce Trautwein to the Lancaster County Veterans Service Committee for a five-year term, commencing July 1, 2012, and ending June 30, 2017.**

MOTION: Hudkins moved and Smoyer seconded approval of the appointment. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- B. **A Lancaster County Visitors Improvement Fund Grant contract in the amount of \$10,000 from Lancaster County, grantor, to Friends of Lied-Lied Center for Performing Arts, grantee, for the purchase of a new light board system. The grant runs through December 31, 2012. (C-12-0341)**

MOTION: Hudkins moved and Smoyer seconded approval of the contract. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

- C. **A resolution in the matter of supplementing appropriations from the previously adopted budget for the Weed Control fund, in the amount of \$4,500. (R-12-0049)**

NEW BUSINESS CONTINUED:

MOTION: Hudkins moved and Smoyer seconded approval of the resolution. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- D. **Special designated license applications from Hillcrest Country Club to provide alcoholic beverage service for events at 9401 O Street, Lincoln, from 6:00 a.m. to 12:00 p.m. on the following days: July 1, August 5, August 12, August 19, September 2 and October 7, 2012.**

Andy Reetz, Hillcrest Country Club General Manager, said Hillcrest has planned golf outings for the Sunday mornings listed on the applications and would like to sell alcoholic beverages at those events. He referred to the City's adoption of Sunday morning alcohol sales and inquired if the County intends to follow the City's policy.

Smoyer said the issue of Sunday morning alcohol sales has been put on a Staff Meeting for discussion. He felt it should be reviewed to be fair to organizations outside the city limits that must compete with organizations inside the City limits.

Raybould questioned if there is enough time to submit the application prior to the July 1 event. Reetz said it was questionable, but he is attempting to process the application anyway.

Hudkins said in June 1992 it was established that beer and wine may be sold off sale between 9:00 a.m. and 1:00 a.m. and other liquor may be sold off sale from 12:00 p.m. to 1:00 a.m. on Sundays (County Resolution 4870). He questioned why the early time of 6:00 a.m. would be needed when sales could start at 9:00 a.m. Reetz said most golf tournaments start between 7:30 and 8:00 a.m. Hudkins verified with Reetz that he knew it could be sold at 9:00 a.m. and that the 6:00 a.m. start time was listed by the Nebraska Liquor Control Commission.

Schorr encouraged Reetz to draft a formal letter to the Board regarding a change in Sunday morning liquor sales.

MOTION: Smoyer moved and Heier seconded approval of the special designated license applications. Raybould, Heier, Smoyer and Schorr voted aye. Hudkins voted nay. Motion carried 4-1.

- E. **A request from Mike Thurber, Lancaster County Corrections Director, for a one-time cash award of \$500 for Corrections Sergeant Derek Contreras under the provisions of Personnel Rule 17.14(d).**

Mike Thurber discussed the contributions of Derek Contreras to the Corrections Department and presented him with an Employee of the Year plaque. Contreras expressed his appreciation and thanked everyone involved.

MOTION: Heier moved and Smoyer seconded approval of the one-time cash award. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- F. **A recommendation from the Purchasing Agent and County Corrections to award a contract to MTJ American, LLC, for 176 mattresses and Derby Industry for 224 mattresses for the new Lancaster County Detention Facility at a total estimated cost of \$38,165.60. (B-12-0029)**

NEW BUSINESS CONTINUED:

Bob Walla, Assistant Purchasing Agent, said the original recommended bid was with Derby Industry, the current supplier, for 400 mattresses at \$43,000. Since then, a protest was received from MTJ American. The protest was rejected based on the experience and references for MTJ; however, it was decided that MTJ should be given a chance, especially considering the price difference of almost \$30 per mattress. MTJ agreed to provide a three-year 100% warranty with the fourth and fifth year at 70%.

Hudkins asked about the cost per mattress. Walla thought MTJ was around \$79 and Derby was around \$108. He said the two types would be put in separate areas so an accurate comparison could be made.

Raybould asked about Derby's warranty. Walla said the warranty is 100% the first year and decreases incrementally to 20% by the fifth year. He added that normally MTJ offers the same warranty, but additional protection was added to show the product would be reliable.

MOTION: Hudkins moved and Raybould seconded approval of the recommendation. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

- G. **An agreement with Midwest Storage Solutions, Inc., for storage equipment and installation at the new Lancaster County Detention Facility. The County shall pay \$149,750.09 for the products and services. The work included in the agreement shall be completed no later than August 15, 2012. (C-12-0342)**

MOTION: Heier moved and Hudkins seconded approval of the agreement. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- H. **A unit price contract between CleanMax, Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for carpet and upholstery cleaning. The County will pay for products and services on an as needed basis according to the line item pricing as listed in the contractor's proposal. Term of the contract is four years from the date of execution by all parties. (C-12-0343)**

MOTION: Raybould moved and Hudkins seconded approval of the contract. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.

- I. **A contract between iPrint Technologies, Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for the annual supply of toner cartridges. The County will pay for products and services according to the line item pricing as listed in the contractor's proposal. Term of the contract is one year from the date of execution by all parties. (C-12-0344)**

MOTION: Raybould moved and Hudkins seconded approval of the contract. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- J. **A contract between The Tree House, Inc., Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for the annual supply of printer cartridges. The County will pay for products and services according to the line item pricing as listed in the contractor's proposal. Term of the contract is one year from the date of execution by all parties. (C-12-0345)**

NEW BUSINESS CONTINUED:

MOTION: Hudkins moved and Raybould seconded approval of the contract. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

MOTION: Hudkins moved and Smoyer seconded approval of the agreements. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- L. **An agreement between Brenda Mueller and Lancaster County, on behalf of the Lancaster County Department of Community Corrections, to provide substance abuse treatment to participants in Pretrial Release and Adult Drug Court. The County shall pay \$25 per hour, not to exceed 25 hours per week, for the services provided. Term of the agreement is July 1, 2012, to June 30, 2013. (C-12-0350)**

MOTION: Heier moved and Hudkins seconded approval of the agreement.

Mike Thew, Deputy County Attorney, said his office had additional questions and recommended the item be held.

The maker withdrew the motion. The seconder concurred.

- M. **A licensure renewal application with the Nebraska Department of Health and Human Services to provide adult day services at the Community Mental Health Center. The County will pay \$300 for the renewal license. (C-12-0351)**

MOTION: Raybould moved and Hudkins seconded approval of the application. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- N. **A Medicare enrollment application for the reassignment of Medicare benefits to the Lancaster County Community Mental Health Center. The application allows Tina M. Vest to reassign her right to bill the Medicare program and receive Medicare payments to the Community Mental Health Center. (C-12-0352)**

MOTION: Raybould moved and Smoyer seconded approval of the application. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

- O. **Acceptance of a grant award from the Nebraska Crime Commission on Law Enforcement and Criminal Justice for the Weekend Reporting Center. The County will receive \$31,050. Term of the grant award is July 1, 2012, to June 30, 2013.**

NEW BUSINESS CONTINUED:

Kit Boesch, Human Services Director, said Items 5O to 5Y are grants approved by the Nebraska Crime Commission that represent alternative activities for youth.

Mike Thew asked to clarify the amount of the grant. Boesch said the Weekend Reporting Center receives \$15,000 from the Crime Commission and \$16,050 from the agency for a total of \$31,050. It was noted that the agenda lists the total amounts rather than the State's share. Boesch submitted breakout information for the grants (Exhibit B).

MOTION: Smoyer moved and Hudkins seconded approval of the grant award. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- P. **Acceptance of a grant award from the Nebraska Crime Commission on Law Enforcement and Criminal Justice for the Children in Shelter project. The County will receive \$87,545. Term of the grant award is July 1, 2012, to June 30, 2013.**

Hudkins asked if a corrected amount (State's share rather than total amount) should be noted for each grant award. Thew said it would not be necessary to specify the correction on each one as long as it is clear that the amount specified on the agenda is the total project cost and the share from the State is a separate figure reported on the grant document.

MOTION: Hudkins moved and Raybould seconded approval of the grant award. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.

- Q. **Acceptance of a grant award from the Nebraska Crime Commission on Law Enforcement and Criminal Justice for the BUILD (Building Up Interdependence and Leadership) project. The County will receive \$40,000. Term of the grant award is July 1, 2012, to June 30, 2013.**

MOTION: Raybould moved and Hudkins seconded approval of the grant award. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- R. **Acceptance of a grant award from the Nebraska Crime Commission on Law Enforcement and Criminal Justice for LEAP (Lincoln Education & Academic Program). The County will receive \$39,000. Term of the grant award is July 1, 2012, to June 30, 2013.**

MOTION: Raybould moved and Hudkins seconded approval of the grant award. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.
