The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 9:30 a.m.

1) **MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, July 3, 2012.**

MOTION: Hudkins moved and Raybould seconded approval of the minutes. Hudkins, Raybould, Heier and Schorr voted aye. Smoyer was absent from voting. Motion carried 4-0.

Smoyer entered the meeting.

2) **CLAIMS: Approval of all claims processed through Tuesday, July 10, 2012.**

MOTION: Heier moved and Raybould seconded approval of the claims. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

3) **SPECIAL PRESENTATIONS:**

- A. **Annual Campaign Against Hunger, July 9-20, 2012 – Scott Young, Food Bank of Lincoln; Minette Genuchi, County Coordinator; and Elaine Severe, City Coordinator. (See 5A for correlating item.)**

Scott Young thanked the County for their contributions to the Food Bank and discussed the large need within the County. He recognized Minette Genuchi and Elaine Severe for their work as County and City coordinators. Young explained the virtual food drive, which allows donations on the Food Bank's web site. Genuchi reminded everyone the employee picnic would take place on Friday, July 13, as well as numerous fundraisers over the next few weeks.

SPECIAL PRESENTATIONS CONTINUED:

- B. Introduction of Roland Morgan and Becky Perrett, appointees to the Lancaster County Visitors Promotion Committee – Jeff Maul, Convention & Visitors Bureau Vice President-Executive Director; and Steve Hilton, Visitors Promotion Committee Chair. (See 5B for correlating item.)**

Jeff Maul noted the functions of the Visitors Promotion Committee, including acting as a consultant to the County Board, monitoring and maintaining a working relation with the Convention and Visitors Bureau, reviewing the budget and making recommendations, and promoting a better understanding and seeking community support in the role of tourism. Maul introduced Roland Morgan and Becky Perrett; each discussed their background.

4) OLD BUSINESS:

- A. Setting the salary of Morgan Smith, Deputy Lancaster County Attorney, at \$56,000 per year, effective June 29, 2012.**

Doug Cyr, Deputy County Attorney, discussed Morgan Smith's background. He said Smith would be covering child support enforcement.

MOTION: Hudkins moved and Smoyer seconded approval of the salary. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

5) NEW BUSINESS:

- A. A resolution proclaiming the period of July 9-20, 2012, as the annual "Campaign Against Hunger". (R-12-0051)**

MOTION: Smoyer moved and Hudkins seconded approval of the resolution. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.

- B. Appointment of Roland Morgan and Becky Perrett to the Lancaster County Visitors Improvement Committee for terms beginning July 1, 2012, and ending June 30, 2016.**

MOTION: Smoyer moved and Hudkins seconded approval of the appointments. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- C. A request for an exceptional circumstance award under Rule 17.9(6) of the Lancaster County Personnel Rules for Minette Genuchi in the amount of \$500.**

Kerry Eagan, Chief Administrative Officer, said Genuchi volunteered to assist Human Services during their transition between administrative assistants. He noted the time involved and the money saved by not hiring a temp for Human Services.

MOTION: Raybould moved and Smoyer seconded approval of the award. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

NEW BUSINESS CONTINUED:

- D. **A letter agreement with the State of Nebraska Department of Roads for federal and state funding to assist the County in the provision of transportation services for the general public in non-urban areas. Federal funds of \$41,817 and state funds of \$20,908, with a County match of \$20,909, shall be provided for the period beginning July 1, 2012, and ending June 30, 2013. (C-12-0393)**

MOTION: Hudkins moved and Raybould seconded approval of the letter agreement. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- E. **A resolution authorizing execution of a construction engineering services agreement with the Nebraska Department of Roads for County Bridge T-108, located on W. Sprague Road between SW 14th Street and SW 2nd Street. (R-12-0052) (C-12-0394)**

MOTION: Heier moved and Hudkins seconded approval of the resolution. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.

- F. **A resolution authorizing execution of a construction engineering services agreement with the Nebraska Department of Roads for County Bridge M-127, located on NW 98th Street at W. Holdrege Street. (R-12-0053) (C-12-0395)**

MOTION: Smoyer moved and Hudkins seconded approval of the resolution. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- G. **A unit price contract between Johnson Controls, Inc., Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for miscellaneous mechanical (HVAC) services. The County will pay for products and services according to the line item pricing as listed in the contractor's proposal. Term of the contract is four years from the date of execution by all parties. (C-12-0396)**

MOTION: Hudkins moved and Heier seconded approval of the contract. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

- H. **A unit price contract between H&S Plumbing, Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for miscellaneous mechanical (HVAC) services. The County will pay for products and services according to the line item pricing as listed in the contractor's proposal. Term of the contract is four years from the date of execution by all parties. (C-12-0397)**

MOTION: Heier moved and Raybould seconded approval of the contract. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- I. **A unit price contract between Capitol Heating & Air Conditioning, Inc., Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for miscellaneous mechanical (HVAC) services. The County will pay for products and services according to the line item pricing as listed in the contractor's proposal. Term of the contract is four years from the date of execution by all parties. (C-12-0398)**

- J. **A unit price contract between Benes Heating & Air Conditioning, Inc., Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for miscellaneous mechanical (HVAC) services. The County will pay for products and services according to the line item pricing as listed in the contractor's proposal. Term of the contract is four years from the date of execution by all parties. (C-12-0399)**

MOTION: Hudkins moved and Raybould seconded approval of the contract. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- K. **An amendment to County Contract C-12-0051 with BVH Architects for engineering and architectural services for space planning for potential renovation of the current Lancaster County Adult Detention Facility (LCADF). The amendment provides for testing of the LCADF reuse ground floor sally port and parking layout at a total cost not to exceed \$3,000. (C-12-0400)**

MOTION: Raybould moved and Hudkins seconded approval of the amendment. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

- L. **An agreement between Dustin Bartley and Lancaster County, on behalf of the Lancaster County Department of Community Corrections, to provide substance abuse treatment to participants in Pretrial Release and Adult Drug Court. The County shall pay \$25 per hour, not to exceed 50 hours per week, for the services provided. Term of the agreement is July 1, 2012, to June 30, 2013. (C-12-0401)**

MOTION: Smoyer moved and Hudkins seconded approval of the agreement. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- M. **An agreement with Electronic Contracting Company for fire alarm inspection services at the Lancaster County Community Mental Health Center. The County will pay \$800 for inspections done in 2012. (C-12-0402)**

MOTION: Heier moved and Smoyer seconded approval of the agreement. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.

- N. **A contract between WARJAR, Inc., on behalf of Wendell Roscoe, MA, LADC, LMHP, and Lancaster County, on behalf of the Lancaster County Mental Health Center, for certified alcohol and drug abuse counselor services. The services will be provided at the rate of \$30 per hour for up to 20 hours per week. Term of the contract is from the date of execution to June 30, 2013. (C-12-0403)**

MOTION: Raybould moved and Hudkins seconded approval of the contract. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

NEW BUSINESS CONTINUED:

- O. **An interlocal agreement with Educational Service Unit (ESU) No. 18 for educational services to youth detained at the Youth Services Center. The County will reimburse the ESU up to \$939,751 for the services provided. Term of the agreement is August 1, 2012, to July 31, 2013. (C-12-0404)**

MOTION: Heier moved and Hudkins seconded approval of the agreement. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- P. **A licensing agreement with Swank motion Pictures, Inc., for showing videocassette movies at the Youth Services Center. The County will pay \$300 for the license. Term of the agreement is July 1, 2012, to June 30, 2013. (C-12-0405)**

MOTION: Smoyer moved and Hudkins seconded approval of the agreement. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

- Q. **An agreement with Kristy Bauer, Attorney at Law, and Lancaster County, on behalf of the Human Services Department, for professional legal services to screen and review juvenile law and truancy violations and to provide assistance with School Multi Agency Response Team meetings and truancy intervention programs. The County shall pay up to \$3,602.58 for the services. Term of the contract is July 1, 2012, to September 30, 2012. (C-12-0406)**

MOTION: Heier moved and Raybould seconded approval of the agreement. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- R. **A political subdivision tort claim filed against Lancaster County Corrections by Troy Smith in the amount of \$452.**

MOTION: Heier moved and Hudkins seconded denial of the tort claim based on the department director's recommendation. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.
