- 1) **MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, July 31, 2012, and the minutes of the County-City joint public hearing held on Tuesday, July 17, 2012.**

MOTION: Smoyer moved and Hudkins seconded approval of the minutes. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.

- 2) **CLAIMS: Approval of all claims processed through Tuesday, August 7, 2012.**

MOTION: Raybould moved and Hudkins seconded approval of the claims. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- 3) **PUBLIC HEARINGS:**

- A. **An amusement license application from Community CROPS for a fundraiser at 4000 West F Street on August 25, 2012. (See 4A for correlating item.)**

The Chair opened the public hearing.

Andrea Anthony, Development Director for Community CROPS, was administered the oath. She discussed the annual fundraiser, which includes dueling local chefs and entertainment (Exhibit A).

The Chair closed the public hearing.

- A. **An amusement license application from Community CROPS for a fundraiser at 4000 West F Street on August 25, 2012.**

MOTION: Raybould moved and Smoyer seconded approval of the amusement license. Smoyer, Hudkins, Raybould, Heier and Schorr voted aye. Motion carried 5-0.

- B. **A special designated license application from Community CROPS to provide alcoholic beverage service for an event at 4000 West F Street, Lincoln, on August 25, 2012.**

MOTION: Raybould moved and Smoyer seconded approval of the special designated license. Hudkins, Raybould, Heier, Smoyer and Schorr voted aye. Motion carried 5-0.

- C. **A 2009 grant adjustment notice to the sub-grant award agreement for 2009 Department of Homeland Security Grant 2009-SS-T9-0061 with the Nebraska Emergency Management Agency as the grantee and Lancaster County as the sub-grantee. The adjustment increases the total award amount to \$409,852.14. (C-12-0445)**

Doug Ahlberg, Emergency Management Director, said the increase would cover amounts not accurately figured in the original grant by the Southeast counties.

MOTION: Heier moved and Smoyer seconded approval of the grant adjustment notice. Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.

- D. **A resolution authorizing the installation of one "Driveway Warning" sign (W2-2mod) on W. Davey Road, 500 feet east of 276 W. Davey Road for westbound traffic. (R-12-0061)**

MOTION: Raybould moved and Hudkins seconded approval of the resolution. Heier, Smoyer, Hudkins, Raybould and Schorr voted aye. Motion carried 5-0.

- E. **A resolution approving the recommendation of the Nebraska Department of Roads to award a bid to Commercial Construction, Inc., for work on County Structure T-108, Project BR-3280(4) – Sprague East. (R-12-0062)**

Scott Gaines, Deputy County Assessor/Register of Deeds, recommended approval of Parcels 17-31-123-007-000 and 17-31-101-001-000 and denial of Parcel 17-18-251-011-000. He said the first two were more appropriately assessed as City and exempt property or railroad and centrally assessed property. The third parcel is still privately owned. Gaines said the refund is for the current year and three prior years.

Scott Gaines, Deputy County Assessor/Register of Deeds, said the Allen and the Holz properties have new housing construction that did not receive building permits. The other five are properties with simultaneous greenbelt applications and valuation protests filed. Each had the value lowered due to the greenbelt and the building lowered due to the referee recommendation. This correlates the two reductions into one notice for those five.

Scott Gaines said AOX Educational Trust is a sorority house that does not meet the definition of educational use, so it is recommended for denial. Reach Out Christian Center and Zion Church have sold so their exemption status would be removed. He recommended approval of the rest, noting Reach Out Christian Center is recommended for partial exemption since a portion of the property is rented.

2012 451 EXEMPTION APPLICATIONS CONTINUED:

Robert Van Valkenburg questioned if the applicants have properly met the requirements for exemption. He encouraged the Board to examine each of the applications closely.

Gaines listed the exemption qualification for each approved applicant:

MOTION: Heier moved and Hudkins seconded approval of the 451 exemption applications recommended by the County Assessor.

Schorr clarified that the applications listed were being approved with the exception of AOX Educational Trust, Reach Out Christian Center and Zion Church, as well as a partial exemption for Redeemer, PCA.

ROLL CALL: Raybould, Heier, Smoyer, Hudkins and Schorr voted aye. Motion carried 5-0.


7) **REVIEW OF 2012 451 EXEMPTION:**

Community CROPS Sunset Community Farm Feast on the Farm Layout - 8/25/12



WRIT OF MANDAMUS

A writ or order of mandamus is an extraordinary court order because it is made without the benefit of full judicial process, or before a case has concluded. It may be issued by a court at any time that it is appropriate, but it is usually issued in a case that has already begun.

The writ of mandamus can also be issued in a mandamus proceeding, independent of any judicial proceeding. Generally, such a petition for a mandamus order is made to compel a judicial or government officer to perform a duty owed to the petitioner. For example, in Massachusetts, each year the commonwealth's attorney general and each district attorney must make available to the public a report on wiretaps and other interceptions of oral communications conducted by law enforcement officers. If the report is not made available, any person may compel its production by filing an action for mandamus (Mass. Gen. Laws Ann. ch. 272, § 99 [West 1996]). If successful, a court would iss [Latin, We comand.] A writ or order that is issued from a court of superior jurisdiction that commands an inferior tribunal, corporation, Municipal Corporation, or individual to perform, or refrain from performing, a particular act, the performance or omission of which is required by law as an obligation. ue an order directing the attorney general and district attorneys to produce the information. The attorney general and district attorneys have a chance to defend their actions at a hearing on the action. If the parties fail to comply with a mandamus order, they may be held in Contempt of court and fined or jailed.
