The Chair called the meeting to order at 10:30 a.m. and the location of the Nebraska Open Meetings Act was announced.

1) **PLEDGE OF ALLEGIANCE**

2) **MINUTES: Approval of the minutes of the Board of Commissioners meetings held on Tuesday, July 22, 2014.**

**MOTION:** Smoyer moved and Raybould seconded approval of the minutes. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

3) **CLAIMS: Approval of all claims processed through Tuesday, July 29, 2014.**

**MOTION:** Raybould moved and Amundson seconded approval of the claims. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

4) **SPECIAL PRESENTATION:**

- A. **Lancaster County Visitors Improvement Fund Grant to the Lied Center for Performing Arts – Friends of Lied for a main auditorium digital soundboard and canopy signage – Bill Stephan, Lied Center for Performing Arts – Friends of Lied Executive Director. (See 5A for correlating item.)**

Bill Stephan distributed the 2014-15 Lied Center schedule (Exhibit A). He discussed improvements being made to the facility with immediate implementation of the soundboard and September placement of the signage. Stephan noted that season ticket sales are at the highest level since 2002.

5) **NEW BUSINESS:**

- A. **Lancaster County Visitors Improvement Fund grant contract in the amount of \$89,862.08 with Lancaster County (Sponsor) and the Lied Center for Performing Arts – Friends of Lied (Grantee) for a main auditorium digital soundboard and canopy signage. Grant period is April 1, 2014, to September 30, 2014. (C-14-0376)**

Hudkins explained that grant funds come from lodging tax, not property tax.

**MOTION:** Smoyer moved and Amundson seconded approval of the contract. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

- B. **Special designated license application from the VFW Post 3606 for an event on August 29, 2014, at 3340 West A Street, Lincoln.**

- C. **Amusement license amendment from JK's Pumpkin Patch to include an event on Sunday, September 14, 2014.**

Josh Kadavy said the Nebraska Kids TRUTH Campaign wants to hold a Color 5k Walk/Run fundraiser on his property. He would like to amend his amusement license to include the event.

**MOTION:** Smoyer moved and Raybould seconded approval of the amusement license amendment. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

- D. **Resolution in the matter of directing the County Engineer to conduct a study regarding vacating portions of SW 28<sup>th</sup> Street, W. Simon Street and W. Frye Street, more particularly described in Exhibit "A" and located in Martell, Lancaster County, Nebraska. (R-14-0041)**

**MOTION:** Raybould moved and Amundson seconded approval of the resolution. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

- E. **Recommendation from Purchasing and Emergency Management to issue a contract to QSA Global, Inc., in the amount of \$62,940.17 for the purchase of a package x-ray system using GSA contract GS-07F-0280T. (B-14-0029)**

**MOTION:** Amundson moved and Smoyer seconded approval of the recommendation. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

- F. **Contract with Concrete Industries, Inc., for the annual supply of asphaltic joint sealant. (C-14-0377)**

**MOTION:** Amundson moved and Schorr seconded approval of the contract. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

- H. **Contract between NMC, Inc., Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for the annual requirements of equipment and accessory rental. Term of the contract is three years from the date of execution by all parties. (C-14-0379)**

**MOTION:** Amundson moved and Raybould seconded approval of the contract. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

- I. **Contract between Hamilton Equipment Company, Lancaster County, the City of Lincoln and the Lincoln-Lancaster County Public Building Commission for the annual requirements of equipment and accessory rental. Term of the contract is three years from the date of execution by all parties. (C-14-0380)**

- J. **Amendment to County Contract C-13-0379 with Cross-Dillon Tire for tires, tubes and tire repair services. The amendment renews the agreement for an additional one-year term from August 6, 2014, to August 5, 2015. (C-14-0381)**

**MOTION:** Schorr moved and Raybould seconded approval of the amendment. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

- K. **Amendment to County Contract C-13-0378 with Bauer Built Tire & Service for tire, tubes and tire repair services. The amendment renews the agreement for an additional one-year term from August 6, 2014, to August 5, 2015. (C-14-0382)**

- L. **Amendment to County Contract C-13-0495 with Datashield Corporation for document shredding services. The amendment renews the agreement for an additional one-year term from July 15, 2014, to July 14, 2015. (C-14-0383)**

- M. **Memorandum of understanding with Nationwide Title Clearing, Inc., for electronic filing/recording of records with the Lancaster County Register of Deeds. There is no cost to the County. (C-14-0384)**

**MOTION:** Raybould moved and Amundson seconded approval of the memorandum of understanding. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.

- N. **Interlocal agreement between the Nebraska Department of Administrative Service, Lancaster County and the City of Lincoln for competitive quotes for printing and mailing services. (C-14-0385)**

Bob Walla, Assistant Purchasing Agent, said a similar interlocal agreement was approved previously. Since then, additional printing and mailing has been done through the State of Nebraska print shop.

Hudkins asked if department heads and elected officials were aware of the service. Walla said there are currently several contracts in place with private companies, so the option will be explored as those expire.

**MOTION:** Raybould moved and Smoyer seconded approval of the agreement. Smoyer, Schorr, Raybould, Amundson and Hudkins voted aye. Motion carried 5-0.

- O. **Interlocal agreement with the Office of Probation Administration in the amount of \$8,000 for electronic monitoring services as part of the operation of the Lancaster County Juvenile Drug Court. Term of the agreement is July 1, 2014, to June 30, 2015. (C-14-0386)**

**MOTION:** Smoyer moved and Amundson seconded approval of the agreement. Schorr, Raybould, Amundson, Smoyer and Hudkins voted aye. Motion carried 5-0.

- P. **Work/Financial Plan update for County Contract C-13-0489 with the United States Department of Agriculture Animal and Plant Health Inspection Service – Wildlife Services for assistance in facilitating wildlife damage management. (C-14-0387)**

**MOTION:** Amundson moved and Smoyer seconded approval of the update. Raybould, Amundson, Smoyer, Schorr and Hudkins voted aye. Motion carried 5-0.

- Q. **Subgrant agreement between the Nebraska Department of Health and Human Services, Division of Children and Family Services Child Support Enforcement, and Lancaster County, on behalf of the Clerk of the District Court, for the Child Support Enforcement Title IV-D State Program. Term of the agreement is October 1, 2014, to September 30, 2015. The Department of Health and Human Services will reimburse the County \$495,955.77. (C-14-0388)**

**MOTION:** Schorr moved and Smoyer seconded approval of the agreement. Amundson, Smoyer, Schorr, Raybould and Hudkins voted aye. Motion carried 5-0.
