RESOLUTION NO. R-00-92

WHEREAS, Lancaster County owns and maintains numerous buildings in the County;
and

WHEREAS, the County has an interest in providing a safe and professional environment
for County employees and the public; and

WHEREAS, the Lancaster County Board is interested in providing a safe and accessible
location for expressive activities at County owned buildings.

WHEREAS, the County Board is interested in content neutral time, place, and manner
regulations with regard to expressive activities.

NOW, THEREFORE, BE IT RESOLVED, by the Lancaster County Board of
Commissioners:

In order to properly regulate the use of the common areas in and around County
Buildings, provided in attachment "A", hereby incorporated by this reference, and to assure that
such areas are reserved for their intended purposes and used in a manner that will promote
efficiency of government and ensure the safety of both employees and member of the public, the
following policies are hereby adopted and approved:

- A. Charitable solicitations that are not County sponsored are prohibited inside all
County Buildings and their respective parking lots.

- B. Charitable solicitations are prohibited from all outside common areas including sidewalk approaches and handicap access ways in a direct line of entry to County Buildings from their respective adjoining parking lots.
- C. Signature gathering and leafleting is prohibited inside all County Buildings and their respective parking lots.
- D. Signature gathering and leafleting is prohibited from all outside common areas including sidewalk approaches and handicap access ways in a direct line of entry to County Buildings from their respective adjoining parking lots.
- E. No displays shall be placed within any common area except that official government displays may be placed in the County Building with County Board approval.
- F. The new Juvenile Detention Center shall be included as one of the County Buildings where these regulations shall apply.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Lancaster County, Nebraska that the foregoing policies are hereby approved and adopted.
