WHEREAS, pursuant to Neb. Rev. Stat. §23-174.10 (Reissue 2007), the Lancaster County Board of Commissioners adopted procedures for the regulation of the operation of body art and piercing establishments in Lancaster County on February 25, 2003, under County Resolution No. 03-0007; and

WHEREAS, the Lincoln-Lancaster County Health Department has recommended an amendment to increase permit fees for the operation of body art and piercing establishments, as provided in Attachment "A," attached hereto and incorporated by this reference; and

WHEREAS, on October 2, 2012, the Board of Commissioners of Lancaster County, Nebraska, conducted a public hearing regarding the adoption of the amendments to Resolution No. 03-0007, Regulation For the Operation of Body Art and Piercing Establishments, as provided in Attachment "A".





ATTACHMENT "A"

CR No. R-03-0007 Regulations for the operation of body art and piercing establishments in Lancaster County, Nebraska

VI. Body Art Establishment; Permit Fees.

The fee for a body art establishment permit shall be as follows:

Body Art Establishment	Initial	Renewal
One (1) to five (5) stations	\$370.00 <u>\$380.00</u>	\$240.00 <u>\$250.00</u>
Each additional five (5) stations	\$150.00 <u>\$155.00</u>	\$110.00 <u>\$115.00</u>

Any initial body art establishment permit issued after the thirtieth of November of each calendar year shall pay seventy percent (70%) of the yearly initial fee. Renewal of all body art establishment permits shall be as required in Section VIII. The fees shall be payable to the Lincoln-Lancaster County Health Department and the Health Director shall deposit the fees at the County Treasurer's Office.

XV. Body Art Practitioner Permit; Fees.

(a) The fee for a body art practitioner permit shall be as follows:

Initial Fee	\$75.00 <u>\$80.00</u>
Renewal Fee	\$35.00 <u>\$45.00</u>

(b) The fees shall be payable to the Lincoln-Lancaster County Health Department and the Health Director shall deposit the fees at the County Treasurer's Office.

XXIX. Body Art Establishment or Practitioner Suspended Permit; Reinstatement Fee.

Any person eligible for reinstatement as provided in Section XXVIII, shall pay a reinstatement fee ~~of 50% of the annual fee~~ of \$190 for a body art establishment permit and \$40 for a practitioner permit in addition to any other applicable fees. The Health Director shall not reinstate the permit until the reinstatement fee is paid.
