RESOLUTION NO. R-15-0019

WHEREAS, Neb.Rev.Stat. §32-217 (Reissue 2008), provides that the County Board shall set the salaries of the Election Commissioner and Chief Deputy at least sixty days prior to the expiration of the term of office of the Election Commissioner; and

WHEREAS, the current term of office of the Lancaster County Election Commissioner expires on September 6, 2015; and

WHEREAS, the Board of County Commissioners of Lancaster County, Nebraska, desires to set the salaries of the Election Commissioner and the Chief Deputy Election Commissioner for the four-year term of office beginning on September 7, 2015 and ending September 6, 2019.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, that the annual salaries and cost of living increases for the Lancaster County Election Commissioner and Chief Deputy Election Commissioner for the term of office commencing September 7, 2015 and terminating September 6, 2019 shall be established as follows:

- 1) Election Commissioner:
 - a. 2015 - \$83,482, commencing September 7, 2015;
 - b. 2016 - Commencing with the first pay period ending in September, 2016, an increase of between not less than 1% and not greater than 2%, depending on the increase in the U.S. Department of Labor Statistics CPI for all Urban Consumers, Mid-West Region as published for November 2015;
 - c. 2017-2018 - Commencing with the first pay period ending in September, an annual increase which is the higher of either 2% OR the increase in the U.S.

Department of Labor Statistics CPI for all Urban Consumers, Mid-West Region as published for November immediately preceding September, but with a maximum increase not to exceed 4%.

- 2) Chief Deputy Election Commissioner:
 - a. 2015 - \$60,107, commencing September 7, 2015;
 - b. 2016 - Commencing with the first pay period ending in September, 2016, an annual increase of between not less than 1% and not greater than 2%, depending on the increase in the U.S. Department of Labor Statistics CPI for all Urban Consumers, Mid-West Region as published for November 2015;
 - c. 2017-2018 - Commencing with the first pay period ending in September, an annual increase which is the higher of either 2% OR the increase in the U.S. Department of Labor Statistics CPI for all Urban Consumers, Mid-West Region as published for November immediately preceding September, but with a maximum increase not to exceed 4%.
- 3) The salary for the Election Commissioner stated herein includes compensation for the Jury Commissioner duties which are assigned to the Election Commissioner.
