### May 13, 2014 - Primary Election

December 2,2013 First day candidates may file for office to have their name placed on the ballot as a candidate at the 2014 Primary Election. (Neb. Rev. Stat. § 32-606)

December 6,2013 Last day for any potential candidate to change his/her party affiliation in order to be eligible to file as a candidate in that party's primary election.

(Neb. Rev. Stat. § 32-612: 1st Friday in December prior to statewide primary)

January 12, 2014 First day to accept early voting request for primary election.

(Neb. Rev. Stat. § 32-941: 120 days prior to election)

February 18 Incumbent filing deadline. (Neb. Rev. Stat. § 32-606)

March 3 Non-Incumbent filing deadline.

(Neb. Rev. Stat. § 32-606)

Deadline for Political Subdivision to submit special issue for primary ballot.

April 7 BY MAIL -- Early Voting begins.

May 7 **4:00 p.m.** -Deadline to accept request for early ballots to be mailed to a specific address.

May 13 PRIMARY ELECTION DAY
