- 12-1-14 First day Election Commissioner may accept candidate filings for Lincoln Public School Board **

- 12-8-14 First day Election Commissioner can accept early voting ballot requests for Primary election.
120 days prior to Primary

- 2-17-15 **Incumbent filing deadline for Lincoln School Board.**

Last day for candidates for City Council and Airport Authority to withdraw.

- 4-6-15 Last day to vote an Early Voter’s ballot in the Election Office. Open until 5:00 p.m.

- 4-7-15 CITY AND SCHOOL PRIMARY ELECTION** (4th Tuesday preceding date of General Election) *Lincoln City Charter, Article IV, Section 2*
Polling sites are open from 8:00 a.m. – 8:00 p.m.
Last day to request early voter’s ballot by appointing agent to pick up ballot by 7:00 p.m. and return by closing of polls. *Nebraska Revised Statutes § 32-943*

Last day to file as **Write-in** candidate (10 days before election)

- 4-29-15 Last day (4:00 p.m.) a voter may request an Early Vote/Absentee be mailed to a specific address

- 5-5-15 CITY AND SCHOOL GENERAL ELECTION** --1st Tuesday in May
