FEDERAL OFFICE

Representative in Congress - District #1

- Partisan Race
- 2 year term.
- Filing fee: Pay \$1,693 to the Nebraska Secretary of State.
- File with Secretary of State.
- Qualifications: Minimum age 25. Must be U.S. citizen for 7 years and a resident of the district.

STATE OFFICES

Governor

- Partisan Race
- 4 year term.
- Filing fee: Pay \$1,050 to the Nebraska Secretary of State.
- File with Secretary of State. Items needed when filing - copy of C-1 form. (This form can be obtained from the Election Commissioner or the Nebraska Accountability and Disclosure Commission).
- File original of C-1 form and Declaration to Abide or Not Abide by Voluntary Expenditure Limits form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Minimum age 30. Must be resident of state for 5 years preceding his/her election, citizen of state and U.S. citizen.

Secretary of State.

- Partisan Race
- 4 year term.
- Filing fee: Pay \$850 to the Nebraska Secretary of State.
- File with Secretary of State. Items needed when filing - copy of C-1 form. (This form can be obtained from the Election Commissioner or the Nebraska Accountability and Disclosure Commission).
- File original of C-1 form and Declaration to Abide or Not Abide by Voluntary Expenditure Limits form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter.

Auditor of Public Accounts

- Partisan Race
- 4 year term.
- Filing fee: Pay \$850 to the Nebraska Secretary of State.
- File with Secretary of State. Items needed when filing - copy of C-1 form. (This form can be obtained from the Election Commissioner or the Nebraska Accountability and Disclosure Commission).
- File original of C-1 form and Declaration to Abide or Not Abide by Voluntary Expenditure Limits form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter.

State Treasurer

Partisan Race

- 4 year term.
- Filing fee: Pay \$850 to the Nebraska Secretary of State.
- File with Secretary of State. Items needed when filing - copy of C-1 form. (This form can be obtained from the Election Commissioner or the Nebraska Accountability and Disclosure Commission).
- File original of C-1 form and Declaration to Abide or Not Abide by Voluntary Expenditure Limits form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter.

Attorney General

- Partisan Race
- 4 year term.
- Filing fee: Pay \$950 to the Nebraska Secretary of State.
- File with Secretary of State. Items needed when filing - copy of C-1 form. (This form can be obtained from the Election Commissioner or the Nebraska Accountability and Disclosure Commission).
- File original of C-1 form and Declaration to Abide or Not Abide by Voluntary Expenditure Limits form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter.

Legislature - Districts 26, 28, 30 and 46

- Nonpartisan Race
- 4 year term.
- Filing fee: Pay \$120 to the Nebraska Secretary of State.
- File with Secretary of State. Items needed when filing - copy of C-1 form. (This form can be obtained from the Election Commissioner or the Nebraska Accountability and Disclosure Commission).
- File original of C-1 form and Declaration to Abide or Not Abide by Voluntary Expenditure Limits form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter and a resident of the district for one year.
- Minimum age 21.

State Board of Education – District 5

- Nonpartisan Race
- 4 year term.
- Filing fee: Pay \$25 to the Nebraska Secretary of State.
- File with Secretary of State. Items needed when filing - copy of C-1 form. (This form can be obtained from the Election Commissioner or the Nebraska Accountability and Disclosure Commission).
- File original of C-1 form and Declaration to Abide or Not Abide by Voluntary Expenditure Limits form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: 1) Cannot be actively engaged in teaching profession; 2) Cannot hold or be a candidate for any other state board office or commission; 3) Must be a citizen of Nebraska; 4) Must be resident of the state at least 6 months and resident of district for a period of 6 months.

Norris Public Power District Board of Directors – Subdivisions 3 & 7

- Nonpartisan Race
- 6 year term.
- Filing fee: Pay \$25.00 to the Nebraska Secretary of State.
- File with Nebraska Secretary of State, 2nd Floor, Items needed when filing - Copy of C-1 form.
- File original of C-1 form with Nebraska Accountability and Disclosure Commission.
- Qualifications: Must be a registered voter and reside within the subdivision. For additional qualifications refer to Nebraska State Statute 70-619.

Lower Platte South Natural Resources District -Subdistricts 1, 3, 4, 5, 6, 7, 8, 9, 10 and At Large

- Nonpartisan Race, 4 year term.
- No filing fee.
- File with Secretary of State.
- Qualifications: Must be a registered voter and reside within the subdistrict.
- At Large candidate must reside within district.

Nemaha Natural Resources District - Subdistrict 1 and At Large

- No filing fee.
- File with Secretary of State.
- Qualifications: Must be a registered voter and reside within the subdistrict. At Large candidate must reside within district.

Southeast Community College - Districts 1, 3, 4 and 5

- Nonpartisan Race, 4 year term.
- No filing fee.
- File with Secretary of State.
- Qualifications: Must be a registered voter and resident of the district at least 6 months prior to the election. No person shall be eligible to membership on the board who is an elected or appointed member of any other board relating to education.

- Filing fee: Pay \$746.02 to the Lancaster County Election Commissioner.
- File with Election Commissioner. Items needed when filing - copy of C-1 form.
- File original of C-1 form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter.

Clerk of District Court

- Partisan Race.
- 4 year term.
- Filing fee: Pay \$782.06 to the Lancaster County Election Commissioner.
- File with Election Commissioner. Items needed when filing - copy of C-1 form.
- File original of C-1 form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter.

County Treasurer

- Partisan Race.
- 4 year term.
- Filing fee: Pay \$782.12 to the Lancaster County Election Commissioner.
- File with Election Commissioner. Items needed when filing - copy of C-1 form.
- File original of C-1 form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter.

County Sheriff

- Partisan Race.
- 4 year term.
- Filing fee: Pay \$1,072.17 to the Lancaster County Election Commissioner.
- File with Election Commissioner. Items needed when filing - copy of C-1 form.
- File original of C-1 form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter. The candidate must hold a law enforcement officer certificate or diploma issued by the Nebraska Commission on Law Enforcement and Criminal Justice (NCLEJ). If the candidate does not possess a certificate or diploma, the candidate must submit to the Election Commissioner, at time of filing, a letter from the NCLEJ certifying the candidate has applied for a background investigation and met the minimum score required of an Adult Basic Education exam, 23-1701.01.

- Qualifications: Must be a registered voter and must be admitted to the practice of the law in Nebraska for at least 2 years and have practiced law actively.

Public Defender

- Partisan Race.
- 4 year term.
- Filing fee: Pay \$1,323.58 to the Lancaster County Election Commissioner.
- File with Election Commissioner. Items needed when filing - copy of C-1 form.
- File original of C-1 form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter and a lawyer engaged in the practice of law in Nebraska.

County Engineer

- Partisan Race.
- 4 year term.
- Filing fee: Pay \$1,047.47 to the Lancaster County Election Commissioner.
- File with Election Commissioner. Items needed when filing - copy of C-1 form.
- File original of C-1 form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter and a registered professional engineer.

Consolidated Office of Assessor and Register of Deeds

- Partisan Race.
- 4 year term.
- Filing fee: Pay \$1,109.08 to the Lancaster County Election Commissioner.
- File with Election Commissioner. Items needed when filing - copy of C-1 form.
- File original of C-1 form with Nebraska Accountability and Disclosure Commission within 5 days of filing for office.
- Qualifications: Must be a registered voter and must hold a county assessor certificate at the time of filing (23-3202). The candidate must present a copy of the County Assessor Certificate to the Election Commissioner at the time of filing.

County Commissioner - Districts 1, 3 and 5

- Filing fee: Pay \$373.01 to the Lancaster County Election Commissioner.
- File with Election Commissioner. Items needed when filing - copy of C-1 form.

- Qualifications: Must be a registered voter and must reside in the district.

- File with City Clerk or Election Commissioner. Item needed when filing - receipt of payment of filing fee.
- Qualifications: Must be a registered voter and a resident of Hickman.

City of Hickman - 3 City Council Members

- Nonpartisan Race.
- 4 year term.
- Filing fee: Pay \$42.00 to Hickman City Treasurer.
- File with City Clerk or Election Commissioner. Item needed when filing - receipt of payment of filing fee.
- Qualifications: Must be a registered voter; have reached the age of majority; and be a resident of Hickman.

City of Waverly - 2 City Council Members
