## Instructions To Voter

This is your ballot for the Otoe County School District 0501 (Palmyra District OR-1) in which you reside. Per Nebraska State Law this election is being conducted through the mail and no polling locations will be used. Below you will find the instructions on how to cast your ballot and return it.

Nebraska Law requires that the signature of an election official must appear at the bottom of your ballot. If there is not a signature on your ballot, please contact the Lancaster County Election Commissioner's Office immediately at (402) 441-7311

### How to Vote the Ballot

- Use a black or blue ink pen to mark your ballot. No pencils or markers please.
- To vote you must blacken the oval completely.
- If you make a mistake in marking your ballot, do not cross out or erase the error. Write "VOID" across the face of the ballot and call the Lancaster County Election Commission at (402) 441-7311 for instructions.

### How to Return the Voted Ballot

- 1) Place the voted ballot in the Identification Envelope and seal. Do Not Place more than one ballot in the envelope.
- 2) Sign the Identification Envelope & Voter's Oath where indicated and provide your street address on the 'Residence Address' line.
- 3) If you are returning your ballot by mail, place postage of \$.49 on the envelope.
- 4) Mail or hand-deliver your ballot to the Lancaster County Election Office, 601 N 46th St., Lincoln. For your convenience, a Drop Box is located outside the main entrance of the office.
- 5) All ballots must be in the possession of the Lancaster County Election Commissioner no later than 5:00 p.m., Tuesday, November 10, 2015.

**Failure to complete and sign the Identification Envelope/Voter's Oath may result in your ballot NOT being counted.**

### SCHOOL BOND SPECIAL ELECTION OTOE COUNTY SCHOOL DISTRICT 0501 (PALMYRA DISTRICT OR-1) IN THE STATE OF NEBRASKA

#### PROPOSITION 1:

"Shall Otoe County School District 0501 (Palmyra District OR-1) in the State of Nebraska issue its bonds in a principal amount not to exceed Eleven Million Three Hundred Eighty-Five Thousand Dollars (\$11,385,000) for the purposes of financing the costs of (a) renovating, rehabilitating and improving the District's existing elementary school building in Bennet, Nebraska, constructing one or more additions to and related site improvements for such building, and acquiring and installing necessary furniture, equipment, and apparatus for such school building and additions, and (b) renovating, rehabilitating and improving the District's existing high school in Palmyra, Nebraska, constructing one or more additions to and related site improvements for such building, including career center, classrooms, a new gymnasium and fine arts space, and acquiring and installing necessary furniture, equipment and apparatus for such school building and additions; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due at such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"

Electors voting in favor of said proposition shall blacken completely the oval opposite the words "FOR said bonds and tax" following said proposition, and electors voting against said proposition shall blacken completely the oval opposite the words "AGAINST said bonds and tax" following said proposition.

## PROPOSITION 2:

"Shall Otoe County School District 0501 (Palmyra District OR-1) in the State of Nebraska issue its bonds in a principal amount not to exceed One Million Five Hundred Sixty-Five Thousand Dollars (\$1,565,000) for the purposes of financing the costs of constructing and installing a track and football field at the Palmyra outdoor athletic and activity space and acquiring necessary equipment and apparatus for such athletic field; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rate or rates, to become due at such time or times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"
