## **SPECIAL MAIL-IN ELECTION CALENDAR**

### **Otoe County School District 0501(Palmyra School District OR-1)**

### **Tuesday, November 10, 2015**

- July 28, 2015 Received official notification from Otoe County School District 0501(Palmyra School District OR-1).
- Certification and Ballot Language received from School District (Neb. Rev. Stat. § 32-559 – at least 50 days prior to election)
- Oct 20 Mail official ballots to all registered voters of **Otoe County School District 0501(Palmyra School District OR-1)**
- Early vote ballots will be sent only to voters requesting that their ballots be mailed to an address different than their address of record and may be sent out prior to this date.
- October 21 - November 10 Ballots returned to Lancaster County Election Commissioner by mail or in person no later than 5:00 p.m. on Tuesday, November 10<sup>th</sup>
- If ballots are returned personally to the Lancaster County Election Commissioner’s Office (601 North 46<sup>th</sup> Street, Lincoln) it may be done during regular business hours (8:00 a.m. – 4:30 p.m.) or dropped off at the Election Commissioner’s Official Ballot Drop Box on the north side of the Election Commissioner’s Office. The drop box is available twenty-four hours a day. On Tuesday, November 10<sup>th</sup> ballots may be personally returned from 8:00 a.m. – 5:00 p.m. (Neb. Rev. Stat. § 32-954)
- October 23 Deadline for voters to complete voter registration applications at agencies including DMV
- Neb. Rev. Stat. Neb. Rev. Stat. § 32-308 and 32-310
- October 23 Deadline for postmark of mail-in voter registrations
- Neb. Rev. Stat. § 32-321-Postmarked on or before third Friday before election
- October 30 Last day for in-person voter registration – Lancaster County Election Commissioner/Otoe County Clerk Offices to be open until 6:00 p.m.
- Neb. Rev. Stat. § 32-302-2<sup>nd</sup> Friday before election
- November 4 Last day a replacement ballot can be sent to voter. (Neb. Rev. Stat. § 32-956)
- November 10 **Palmyra School District OR-1 Special Bond Election.**  
5:00 p.m. -- Deadline for return of **all** ballots (including early vote ballots) to the Lancaster County Election Commissioner’s Office, 601 N. 46<sup>th</sup> St., Lincoln, NE 68503. (Neb. Rev. Stat. § 32-954)
