

NOTICE OF SCHOOL BOND ELECTION

PUBLIC NOTICE IS HEREBY GIVEN to the qualified electors of Lancaster County School District 0161, in the State of Nebraska, that a special election has been called and will be held in said District on the 11th day of September 2007, at which time there will be submitted to the qualified electors of Lancaster County School Dist. 0161 the following proposition:

“Shall Lancaster County School District 0161 (Raymond Central Public Schools), in the State of Nebraska, issue bonds of said District in the principal amount of not to exceed SIXTEEN MILLION ONE HUNDRED THIRTY THOUSAND DOLLARS (\$16,130,000) for the purpose of paying the costs of demolition of certain existing school facilities, construction of new school buildings and facilities and renovation of the remainder of the existing school facilities, and providing for necessary furniture and apparatus for said school buildings and facilities; said bonds to be issued from time to time as may be determined by the Board of Education, to bear interest at a rate or rates to be determined by the Board of Education and to become due at such time or times as may be fixed by the Board of Education; provided, however, any or all said bonds shall be redeemable at the option of the District as provided by law at the time of issuance?” and

“Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in said District sufficient in rate and amount to pay the interest and principal of said bonds as the same become due?”

FOR said bonds and tax

AGAINST said bonds and tax

Qualified electors voting in favor of the proposition shall blacken the oval opposite the words “FOR said bonds and tax” following said proposition, and qualified electors voting against the proposition shall blacken the oval opposite the words “AGAINST said bonds and tax” following said proposition.

The polls will be open continuously from 8:00 A.M. to 8:00 P.M. on said date.
