Instructions To Voter

You are a voter residing in the Lincoln Public Schools District. This is your ballot for the Lincoln Public Schools Special Bond Election. The date of the Election is February 11, 2014. Per Nebraska State Law this election is being conducted through the mail and no polling locations will be used. Below you will find the instructions on how to cast your ballot and return it.

Nebraska Law requires that the signature of an election official must appear at the bottom of your ballot. If there is not a signature on your ballot, please contact the Lancaster County Election Commissioner's Office immediately at (402) 441-7311

How to Vote the Ballot

- Use a pencil or a black or blue ink pen to mark your ballot.
- To vote you must blacken the oval completely.
- If you make a mistake in marking your ballot, do not cross out or erase the error. Write "VOID" across the face of the ballot and call the Lancaster County Election Commission at (402) 441-7311 for instructions.

How to Return the Voted Ballot

- 1) Place the voted ballot in the Identification Envelope and seal. Do Not Place more than one ballot in the envelope.
- 2) Sign the Identification Envelope & Voter's Oath where indicated and provide your street address on the 'Residence Address' line.
- 3) If you are returning your ballot by mail, place one first class postage stamp on the envelope.
- 4) Mail or hand-deliver your ballot to the Lancaster County Election Office, 601 N 46th St., Lincoln, NE 68503
For your convenience, a Drop Box is located outside the main entrance of the Election Office.
- 5) All ballots must be in the possession of the Lancaster County Election Commissioner no later than 5:00 p.m., February 11, 2014.

**Failure to complete and sign the Identification Envelope/Voter's Oath
may result in your ballot NOT being counted.**

"Shall Lancaster County School District 0001 (Lincoln Public Schools) in the State of Nebraska issue its general obligation bonds in an aggregate stated principal amount not to exceed One Hundred Fifty-three Million Two Hundred Ninety-five Thousand Dollars (\$153,295,000), for the purpose of paying the costs of the following: (1) constructing, furnishing and equipping technology and security improvements to facilities of the District, (2) constructing, furnishing and equipping a new elementary school and a new middle school in the southeast area of the District, (3) constructing, furnishing and equipping a career academy high school facility, (4) constructing additions to and furnishing, equipping, renovating, remodeling and repairing facilities of the District, and (5) acquiring sites for school facilities of the District; such bonds to be issued from time to time as may be determined by the Board of Education, to bear interest at a rate or rates to be determined by the Board of Education and to become due at such time or times as may be fixed by the Board of Education; and

"Shall the School District cause to be levied and collected annually a special levy of taxes against all the taxable property in the School District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"

Electors voting in favor of such proposition shall blacken the oval opposite the words "FOR such Bonds and tax" following such proposition, and electors voting against such proposition shall blacken the oval opposite the words "AGAINST such Bonds and tax" following the proposition.
