

Statewide Primary Election Early Vote/Absentee Ballot Request

This early vote/absentee ballot application is for the May 15, 2018 Primary Election. To request an early vote/absentee ballot for this election, *complete the form, sign and return it to the Election Commission* by either mail, email, fax or hand deliver.

If you have an address change within Lancaster County, you may use this form to request an early vote/absentee ballot and update your address.

In accordance with State Law, early vote/absentee ballots will be mailed starting April 9th. If your ballot request is received by my office after April 9th, please allow 3 to 5 working days for us to process and mail your ballot.

Please note that an agent can only act for two voters in one election. A candidate or a member of a candidate campaign committee can only be an agent for his/her own family.

The deadlines for requesting an early vote/absentee ballot are as follows:

Request by mail, fax or email: 6:00 p.m., Fri., May 4, 2018
 Request in person: 5:00 p.m., Mon., May 14, 2018
 Request by agent: 7:00 p.m., Election Day, May 15, 2018
