2008 ELECTION CALENDAR

May 13, 2008 - Primary Election

- Dec 7, 2007 Last day for any potential candidate to change his/her party affiliation in order to be eligible to file as a candidate in that party's primary election.
(Neb. Rev. Stat. § 32-612: 1st Friday in December prior to statewide primary)
- Jan 13, 2008 First day to accept early voting request for primary election.
(Neb. Rev. Stat. § 32-941: 120 days prior to election)
- Feb 15 Incumbent filing deadline.
(Neb. Rev. Stat. § 32-606)
- Mar 3 Non-Incumbent Filing deadline.
(Neb. Rev. Stat. § 32-606)
Deadline for Political Subdivision to submit special issue for primary ballot.
(Neb. Rev. Stat. § 32-559)
- Apr 7 Early Voting starts.
(Neb. Rev. Stat. § 32-808: 35 days prior to election)
- Apr 25 Deadline for mail-in & agency registration.
(Neb. Rev. Stat. § 32-321 & 32-308: 3rd Friday before next election)
- May 2 **6:00 p.m.** Deadline for in-person voter registration.
(Neb. Rev. Stat. § 32-302: 6:00 p.m. on 2nd Friday before election)
- May 7 **4:00 p.m.** -Deadline to accept request for early ballots to be mailed to a specific address.
(Neb. Rev. Stat. § 32-941: Wednesday preceding the election)
- May 13 PRIMARY ELECTION DAY**
(Neb. Rev. Stat. § 32-401: 1st Tuesday after 2nd Monday in May)
7:00 p.m. Deadline for agent to pick up early voting ballot.

8:00 p.m. Deadline for return of early voting ballot.

November 4, 2008 - General Election

- July 6 First day to accept early voting request for general election.

- July 15 Incumbent filing deadline (for offices not on primary ballot).

- Aug 1 Non-Incumbent Filing deadline (for offices not on primary ballot).

- Sept 29 Early voting starts.
(Neb. Rev. Stat. § 32-808: 35 days prior to election)
- Oct 17 Deadline for mail-in & agency registration.
(Neb. Rev. Stat. § 32-321 & 32-308: 3rd Friday before next election)
- Oct 24 **6:00 p.m.** Deadline for in-person voter registration.
(Neb. Rev. Stat. § 32-302: 6:00 p.m. on 2nd Friday before election)
- Oct 29 **4:00 p.m.** -Deadline to accept request for early voting ballots to be mailed to a specific address.

- Nov 4 GENERAL ELECTION DAY**
(Neb. Rev. Stat. § 32-401: 1st Tuesday after the first Monday in November)
7:00 p.m. Deadline for agent to pick up early voting ballot.

8:00 p.m. Deadline for return of early voting ballot.
