Notice is hereby given, that on Tuesday, May 15, 2012, at the usual polling places in the precincts of Lancaster County, Nebraska, an election will be held. The polls will be open at 8:00 o'clock a.m. and close at 8:00 o'clock p.m.

Said election will be for the nomination of candidates to various offices and a special issue for the Freeman Public Schools.

Delegates to the political party post-primary county conventions for all the precincts in Lancaster County wherein candidates for such offices have filed, shall receive a certificate of election.

Unless otherwise noted, the voter may vote for one (1) candidate per contest.

GAGE COUNTY SCHOOL DISTRICT 0034 (FREEMAN PUBLIC SCHOOLS) IN THE STATE OF NEBRASKA

“Shall Gage County School District 0034 (Freeman Public Schools) in the State of Nebraska (the “District”) issue its bonds in a principal amount not to exceed FOUR MILLION FOUR HUNDRED FIFTY THOUSAND DOLLARS (\$4,450,000) for the purpose of financing the costs of constructing additions to and renovations of the District’s facilities, including, but not limited to, the expansion of the existing commons area, the construction of a gymnasium addition, the improvement of certain athletic facilities, and other renovations of and improvements to such existing facilities, and acquiring necessary furniture and apparatus for such facilities and additions (the “Project”), said bonds to be issued from time to time, to bear interest at a rate or rates, to become due at such time or times, and to have such other terms and provisions, all as may be fixed by the Board of Education of the District; and

“Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the interest and premium on and the principal of the bonds as the same become due?”

- FOR said bonds and tax
- AGAINST said bonds and tax

Electors voting in favor of said proposition shall blacken completely the oval opposite the words “FOR said bonds and tax” following said proposition, and electors voting against said proposition shall blacken completely the oval opposite the words “AGAINST said bonds and tax” following said proposition.

In compliance with Section 32-811 R.R.S. Nebraska Statutes in those cases where the names of candidates properly filed for nomination do not exceed two candidates for each vacancy to be filled, the candidates shall be declared nominated and the races/candidates will not appear on the primary ballot. The following races/candidates meet this requirement and will not appear on the primary ballot, but will appear on the Nov 6, 2012 General Election Ballot.
