Election Calendar for Mail-In Election  
Election Date: Sept. 15, 2015**

- Jul 26      Deadline to receive official certifications from Road Improvement Districts
- Neb. Rev. Stat. § 32-559 – at least 50 days prior to election
- Jul 31      Last day for candidate to file for election
- Neb. Rev. Stat. § 32-1606 – 45 days prior to the election
- Aug 25      1<sup>st</sup> day to mail official ballots to all registered voters of **the Road Improvement Districts**
- Early vote ballots will be sent only to voters requesting that their ballot be mailed to an address different than their address of record and may be sent out prior to this date.
- Aug 25 -  
- Sept 15      Ballots returned to Lancaster County Election Commissioner by mail or in person  
no later than 5:00 p.m. on Tuesday, September 15, 2015.
- If ballots are returned personally to the Lancaster County Election Commissioner’s Office (601 North 46<sup>th</sup> Street, Lincoln) it may be done during regular business hours (8:00 a.m. – 4:30 p.m.) or dropped off at the Election Commissioner’s Official Ballot Drop Box on the north side of the Election Commissioner’s Office. The drop box is available twenty-four hours a day. On Tuesday, September 15<sup>th</sup> ballots may be personally returned from 8:00 a.m. – 5:00 p.m. (Neb. Rev. Stat. § 32-954)
- Aug 28      Deadline for voter registrations from agencies including DMV to be completed
- Neb. Rev. Stat. Neb. Rev. Stat. § 32-308 and 32-310
- Aug 28      Deadline for postmark of mail-in voter registrations
- Neb. Rev. Stat. § 32-321-Postmarked on or before third Friday before election
- Aug 28      Deadline for voter registrations by Deputy Registrar -- 6:00 p.m.
- Neb. Rev. Stat. § 32-306-3rd Friday preceding election.
- Sept 4      Last day to mail out ballots.
- Neb. Rev. Stat. § 32-953-Not later than the 10<sup>th</sup> day before the date of the election.
- Sept 4      Last day for in-person voter registration – Election Commissioner Office - open until 6:00 p.m.
- Neb. Rev. Stat. § 32-302-2<sup>nd</sup> Friday before election
- Sept 9      Deadline to mail out Early Voting Ballots to voters requesting that their ballots are to be mailed to an address different than their address of record.
- Neb. Rev. Stat. § 32-941 - 4:00 p.m. on the Wednesday preceding election
- Sept 9      Last day a replacement ballot can be sent to voter.
- Neb. Rev. Stat. § 32-956 -4<sup>th</sup> business day before election
- Sept 15      **Road Improvement District Election Day.**
- Neb. Rev. Stat. § 32-1606 - 1<sup>st</sup> Tuesday after 2<sup>nd</sup> Monday in Sept
- 5:00 p.m. -- Deadline for return of **all** ballots including early vote ballots, to be returned to Lancaster County Election Commissioner’s Office, 601 N. 46<sup>th</sup> St., Lincoln, NE 68503 (Neb. Rev. Stat. § 32-954)
