WHAT TO BRING TO HAVE YOUR TAXES PREPARED

- Photo ID
- W-2's from your employer, 1099's for miscellaneous income, and W2-G's for gambling income
- 1099's for interest, dividends, unemployment, retirement, and other income
- Social Security cards or ITIN letters (for you, your spouse, your children, and other dependents)
- Copy of last year's tax return (very helpful), **necessary** for MyFreeTaxes self-prep
- Childcare information (provider's ID number and address & receipts for amount paid)
- Blank Check or savings account information for direct deposit
- Statements of student loan interest, mortgage interest and property tax
- List of any other income and expenses

PLEASE NOTE: If your return has transactions that are beyond the scope of the VITA volunteers' training, VITA volunteers cannot prepare the return.

This **includes**, but is **not limited** to the following:

- **CANNOT** prepare the return if a **Depreciation schedule** is required
- **CANNOT** prepare the return if a **Schedule E (Rental)** or a **Schedule F (Farm)** is required.
- **MAY** be able to prepare the return if there is income from **dividends or capital gains** or if there are **minimal brokerage transactions**.

If you have income from a state **OTHER THAN NEBRASKA**

- VITA volunteer **CAN** prepare the **FEDERAL** tax return.
- VITA volunteer **CAN** prepare the **Nebraska** tax return if you are a **partial-year Nebraska resident**.
- VITA volunteer **CANNOT** prepare the **Nebraska** tax return if you are a **full-year Nebraska resident with income from another state**.
- VITA volunteer **CANNOT** prepare a state tax return for **states other than Nebraska**.
- VITA volunteer can assist in locating a volunteer who **may be able** to prepare these returns 'off site.'
