

**2019 Lincoln City Elections Early Voting Ballot Application**

This is your early voting ballot application for the April 9, 2019 Lincoln City Primary Election and May 7, 2019 General Election. To request an early voting ballot for one or both elections, complete the form, sign and return it to the Election Commission by mail, email, fax or hand delivery.

**If you have an address change within Lancaster County**, you may use this form to update your address and request an early voting ballot.

A person may assist up to two voters by acting as their agent. An agent can complete and submit the early voting ballot application on behalf of the voter. A candidate or a member of a candidate campaign committee can only be an agent for his/her own family.

Ballots will be mailed to voters beginning March 25 for the Primary Election and April 22 for the General Election.
