Our staff will be available to train anyone wishing to join the Weed Watcher Program. The program includes a Weed Watcher Resource Guide, a photo calendar to help you identify invasive plants as they grow throughout the season. A hit report is available to give you a way to report infestations. Our Weed Watcher program is designed to train and support volunteers to find and report new occurrences of harmful invasive

plants. Weed Watchers help protect natural areas from the impacts of invasive plants by detecting new populations early before they get out of hand.

Weed Watchers are people who care about the health of our lands and want to help prevent the ecological and economic damage associated with plant invasions by looking for and reporting new weeds.

Weed Watchers can be anyone; private citizens who simply want to scan for new invaders while they trek across the land to experts in the field. Often Weed Watchers are people already actively volunteering in their community. Outdoorsmen, hunters and fishermen, community groups, geocachers, 4-H groups, boy & girl scouts, are just a few of the groups than can help make a difference.

Good Neighbors – Control Invasive Weeds!!!

It is the duty of each person who owns or controls land to effectively control noxious weeds on such land.

Noxious weed is a legal term used to denote a destructive or harmful weed for the purpose of regulation.

The Director of Agriculture establishes which plants are noxious. These non-native plants compete aggressively with desirable plants and vegetation. Failure to control noxious weeds in this state is a serious problem which is detrimental to the production of crops and livestock, and to the welfare of residents of this state. Noxious weeds may also devalue land and reduce tax revenue
